**Memorandum of Agreement (MoA)**

**And**

The Institute of Punjabi University, Patiala through its authorized signatory

Where the Institute of is not for profit organization and engaged in academic, patient care and/or research in physiotherapy in women health fields.

Whereas both the above parties after discussions having signed the Memorandum of Agreement (MoA) which will lay the foundation for cooperation and joint action related to matters of mutual interest and decided to deduce their respective roles jointly here under:

**1. OBJECTIVES AND CONDITIONS OF MoA:**

- A) Both the parties decided to work closely on the proposed research project entitled," A multifactorial study of maternal physical, psychological and health parameters for early prediction of gestational diabetes mellitus in pregnant women". This study will be an attempt to enhance the knowledge in the fields of physiotherapy in women health, with reference to the project.
- B) Dr. Aashima Arora, Department of Obstetrics and gynecology, PGIMER, Chandigarh and Dr. Sonia Singh (PI) FROM The Institute of Punjabi University, Patiala will supervise the above mentioned research project.
- C) The department of Obstetrics and gynecology, PGIMER, Chandigarh will provide patients and blood investigations relevant to the proposed project. The clinical samples/ infectious materials shall be sent outside the country (if necessary) only after approval of the competent authority and the number of samples to be decided by the competent authority. The confidentiality of the samples will be protected.
- D) The Physiotherapy department in Punjabi university, Patiala will be (Collaborating institute) Providing necessary professional guidance relevant for the project.
- E) Both the parties will have academic/commercial interest in this project.
- F) The important research finding arising out of the activities covered under this MoA may be published in peer reviewed national and International journals. All the participants from the collaboration Institutes will be co-authors in research papers that emanate from the proposed project work.
- G) This study will/will not involve any type of animal models or radioactive material. Clearance from the respective committees will be obtained as per the need.
- H) This study will/will not deal with treatment issues.
- I) If any IPR develops from the proposed collaborative project between PGIMER, Chandigarh and Punjabi university, Patiala the benefits will be shared equally between the institutes.
