Terms and conditions:-


1. Earnest Money and Tender form fee, separately of requisite value, shall be submitted in shape of DD of any Nationalized Bank payable in favour of **Executive Engineer, Punjabi University Patiala**. The Demand Draft must be submitted on or before 12-02-2020 till 10:00 A.M. in the Office of **Executive Engineer**, Tender will be opened in the office of Executive Engineer Punjabi University Patiala.
2. Tender Processing fee should be paid through e- payment Direct Debit or Internet Banking.
3. Bid Security and Tender Processing fees should be deposited before opening the tender.
4. The Tender documents shall be uploaded in 2 folders.
 - (i) **Folder-A:** Shall contain pre qualification documents such as Enlistment, PAN No., GST, Labour Registration certificate, Income Tax Return and Non Black list Self certificate etc uploaded on website.
 - (ii) **Folder-B:** shall contain financial bid on the prescribed form.
5. In case earnest money and Tender Fee is not deposited for not having of the required value, the bids will not be considered and rejected straightaway.
6. The Tenders will be opened only of those Firm/Tenderers whose earnest money and Tender Fee is found to be in order.

PRE-QUALIFICATION REQUIREMENTS:-

- 1) The contractor / firm shall be enlisted with State, PWD / CPWD/ Railways/ P.S.P.C.L./ M.E.S./ PUDA etc.
- 2) The Tenderers /Firm shall submit a copy of PAN No., GST No. etc.
- 3) In case firm employed less than 20 workers at site. Affidavit by firm must be attached that firm has no need for Labour Registration Certificate.
- 4) Copies of income tax return for the last 2 years showing amount of works executed during these years.
- 5) The Tenderers /Firms shall submit Self certification that they have not been debarred/black listed by any Govt/Semi Govt. Organization or any Corporation at any stage.

TERMS AND CONDITIONS

1. Conditional tender or tenders without earnest money are liable to be rejected.
2. If there is holiday on the opening day of the tender, the tender shall be received/ opened on the next working day at the same time and at the same place.
3. The Engineer in charge reserves the right to reject any or all the tenders. He also reserves the right to reject the tender as a whole or delete any item of the tender without assigning any reason before/after opening of the tenders and the tenderer shall have no right or any claim what so ever for the same on this account.
4. The quantity of any items of the work can be increased or decreased or deleted all together as per the requirement at site. The scope of work can be increased/decreased. The contractors shall have no right of any claim what so ever for the same on this account.
5. The Firm shall quoted their rate in below/ At par / Above as applicable)
6. Cement and Steel will be used by the Contractor at site his own cost.
7. The Contractor shall comply with the proper bye- Laws and legal order of the local body or authority under the jurisdiction of which the work is executed, and pay all fees and charges for which he may be liable. Nothing extra shall be payable by the University on this account.
8. Contractor shall require to registration of building and other construction workers under the Act as directions dated 18-01-2010 given by Hon'able Supreme Court in Writ petition (Civil) No. 318 of 2006 titled as National Complain Committee of Central Legislation on Construction Labour versus Union of India and others and extension of benefits to such Registered workers under this Act.
