

## Final Seat Allotment for LL. B. 3 Years 2nd Councelling (other State)

**Reporting of Students in allotted Departments/Institute for Document verification and Fee Submission -12 August 2017 (9 AM) and 14 August 2017 (5 PM).**

- 1. Candidates who Seat Allocated their seat (paid fees) and have not been promoted to better preference institute/ colleges have not been included in the List (Same College Allocated).**
- 2. Seat allotment is subject to the verification of certificates/ documents and fulfillment of conditions/ essential qualifications and eligibility criteria as postulated in the ordinances of the course schemes of respective universities.**
- 3. Candidates must bring all original certificates (Date of Birth, Residence Proof, Category Claim, DMC of Qualifying Class, Gap Certificate if required, Character Certificate from Institute/ College (from where you have Passed last examination) for verification and submit self-attested photo-copies of certificates and other relevant documents. Incomplete/ Inappropriate documents will not be entertained. FURNISHING WRONG INFORMATION, IF ANY, OR NOT HAVING SUPPORTING DOCUMENTS WILL LEAD TO THE CANCELLATION OF THE CANDIDATURE.**
- 4. The selected candidate must report at the allotted Institute/Department strictly as per the schedule (12 August 2017 (9 AM) and 14 August 2017 (5 PM)), failing which, the allotted seat automatically stands cancelled.**
- 5. Checking/ verifications of the documents is the sole responsibility of the concerned department/ Institution.**
- 6. Candidates in the General category/ reserved category who have been allotted first preference of their choice and do not report to the concerned Department/ Institute or do not deposit fees within the stipulated time, their claim for admission stands cancelled.**
- 7. Candidates who have been allotted lower preference than their first preference Department/ Institute will be allowed to change their preference order in the third round of counselling.**
- 8. The third counselling will be carried out by allocating seats first to all the reserved categories and Other State(15%) categories except Punjab 85% General Category seats. After that vacant seats of reserve categories and Other State will be added in Punjab State 85% seats and will be allocated to the remaining candidates during the third round of counselling.**
