

Extension in date of Notice Inviting quotation

This is with reference to the Notice Inviting Quotation (NIQ No. 4874/UCC dated 20.08.2025) issued by the Dean Research, Punjabi University, Patiala, for the purchase of a subscription to Plagiarism Detection Software. The last date for submitting quotations, originally fixed as 11.09.2025, is now extended to **09.10.2025 up to 5:00 p.m.** Vendors who have already submitted their quotations are not required to resubmit. However, if they wish to revise their rates, only the **latest quotation submitted** will be considered. The details of NIQ 4874/UCC dated 20.08.2025 are given below.

- **License Validity:** The subscription will remain valid for **18 months** from the date of activation or license handover.
- **Invoice & Payment Terms:**
 - Payment will be made as per institutional norms upon satisfactory activation of the PDS services.
 - All government taxes must be clearly indicated in the invoice.
- **Compliance**

The software must adhere to **best practices in research ethics, academic integrity, and originality assurance** as outlined in these frameworks. Additionally, the product shall be **future-compliant with the immediate effect**, with built-in flexibility to **adapt to any updated or newly introduced norms** issued by UGC, INFLIBNET, or other statutory and accrediting bodies. The vendor shall be responsible for ensuring that updates and enhancements to the software are made available to the University in a timely manner, as and when such regulatory changes occur.
- Prices must be inclusive of all taxes, setup charges, and training sessions.
- GST No. of the vendor must be mentioned in the quotation.
- The prices must be in Indian Rupees only. The payment will be made in the Indian Account. All taxes and levies as per India are must. The Vendor must have the Indian Bank Account, PAN and GST Number.
